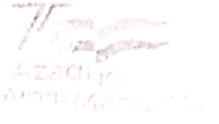

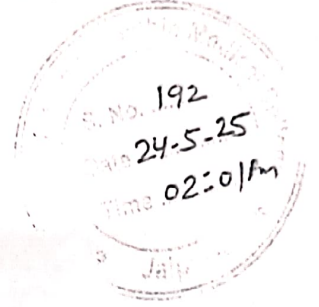

Sub: Application for letter of permission for functioning of Dr. M.P.K Homoeopathic Medical College, Homoeopathy Plot No.10-11 & 12, Village Saipura, Sanganer, Jaipur – 302029 for conducting BHMS course with 100 UG seats and 34 seats for PG course in 06 subjects with 6 seats in Homoeopathic Philosophy, 06 seats in Materia Medica, 6 seats in Repertory, 6 seats in Homoeopathic Pharmacy, 6 seats in Practice of Medicine, 04 seats in Pediatrics for the academic year 2025-26- regd.

Sir,

Dr. M.P.K Homoeopathic Medical College, has applied for permission for sanction of BHMS course with 100 seats and 34 seats for M.D (Hom) in 06 subjects with 6 seats in Homoeopathic Philosophy, 06 seats in Materia Medica, 6 seats in Repertory, 6 seats in Homoeopathic Pharmacy, 6 seats in Practice of Medicine, 04 seats in Pediatrics each for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 14.02.2025 & 15.02.2025, followed by hearing on 15.05.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

1. Teaching faculty.

- Associate Professor in Department of Anatomy.
- Assistant Professor in Department of Organon of Medicine.
- Professor in Department of Materia Medica
- Assistant Professor in the Department of Pathology.
- Associate professor in Department of Community of Medicine.
- Associate Professor and Assistant Professor in Department of Repertory

As evident from the above statement, a total number of seven teachers are deficient against the requirement of 40+1 for 100 seats UG college (As specified in MES,2024). Pursuant to F.No.:3-2/MARBH/NCH/2025-26/162-169 dated 16/04/2025 issued by MARBH, a college can avail 10% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 10%, college still has deficiency of three teachers in UG Department. However, such relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

2. Miscellaneous

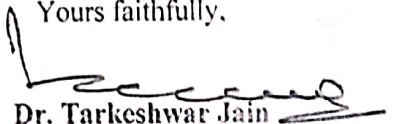
- NABL accreditation for clinical laboratory not done.
- The salary of teaching staff and non-teaching staff is not as per MES 2024.

3. Considering the above observations during inspection and hearing, MARBH has decided to issue Conditional Permission to Dr. M.P.K Homoeopathic Medical College, Homoeopathy Plot No.10-11 & 12, Village Saipura, Sanganer, Jaipur - 302029 for conducting BHMS course with 100 UG seats and 34 seats for PG course in 06 subjects with 6 seats in Homoeopathic Philosophy, 06 seats in Materia Medica, 6 seats in Repertory, 6 seats in Homoeopathic Pharmacy, 6 seats in Practice of Medicine, 04 seats in Pediatrics on the basis of following condition:-

- The salary of the staff should be as per the criteria mentioned in MES 2024.
 - Associate Professor in Research methodology and Biostatistics Department should be appointed.
 - A separate visiting faculty of minimum cadre of Assistant Professor for teaching fundamentals of psychology to be appointed.
 - NABL accreditation for clinical laboratory at the earliest.
 - Deficiency of three teachers in UG Department to be removed.
4. All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 UG seats and 34 PG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or, shall be conducted by the concerned counseling authority of the state/UT.
5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.
6. Conditions under point 3 should be fulfilled within a period of one month and the compliance report shall be submitted for verification to the office, failing which permission for the academic year 2025-26 may be withdrawn.
